# Over 70 ha protected for biodiversity thanks to a third donation from a Bolton-Est landowner

**Bolton-Est, Friday February 16<sup>th</sup>, 2018** – The conservation groups Conservation des vallons de la Serpentine (CVS) and Appalachian Corridor are pleased to announce the protection in perpetuity of a 70-hectare property in Bolton-Est. This new protected area is the third ecological gift from Ms. Ann Pâquet, and CVS will now be its sole owner. Over the years, Ms. Pâquet developed lasting relationships based on mutual trust with both conservation organizations, which led her to protect a total of 80.6 ha in an area of high ecological value. Ms. Pâquet explains: "all these people have inspired me confidence and over the years I developed a great interest in nature; therefore, I now give 70 hectares to CVS for their protection in perpetuity". Gilles Gagnon, Vice President, Communications for CVS adds that "it is a great privilege to have worked with Ms. Pâquet over the last ten years to protect the biodiversity of her land and we are most grateful. This new protected area features numerous elements of ecological interest and brings the network of natural areas protected by CVS to 340 ha (850 acres)".

#### A donation to safeguard connectivity

Appalachian Corridor and CVS thank Ms. Pâquet wholeheartedly for this land donation in a strategic and highly sought-after area. "This is an invaluable gift that fits perfectly with our conservation strategy. Owing to its location, it contributes to connectivity efforts for wildlife protection in the Green Mountains linkage from Vermont to Quebec. We hope that the mutual trust highlighted with this third donation will inspire new donors and initiate other projects" said Mélanie Lelièvre, Executive Director at Appalachian Corridor. The land is located between Mount Orford and Mount Place where wildlife movements abound. The protection of this property will ensure quality habitats are safeguarded for various species representative of the natural region, including the Northern Dusky Salamander, a species at risk in Quebec (likely to be designated as threatened or vulnerable under the *Loi sur les espèces menacées ou vulnérables*).

#### A landowner who makes all the difference

It should be noted that conservation actions in the Mont Chagnon area started almost a decade ago thanks to Ms. Pâquet. Indeed, the generous property-owner made a first land donation in 2009, which represented the first dominant land for the local conservation group (CVS). With this first ecogift, CVS was

then able to protect many other natural habitats in the surrounding area by way of conservation servitudes.

"On behalf of my colleague, Catherine McKenna, I congratulate Conservation des vallons de la Serpentine, Appalachian Corridor and their partners for the conservation of 70 hectares of important habitat in Bolton-Est. Through the Natural Areas Conservation Program and the Ecological Gifts Program our government is working with partners to protect and conserve species at risk, and preserve Canada's biodiversity for future generations" said the Honourable Denis Paradis, MP for Brome-Missisquoi.

Beyond their convictions, some of them took direct action by giving CVS a portion of their properties or by granting conservation servitudes in perpetuity.
